I. Meeting called to Order

Commerce Secretary Kevin Anderson called the meeting to order at 10:32am.

II. Review and Approval of October 16, 2023 Meeting Minutes

Upon a motion duly made and seconded, the minutes of the October 16, 2023 meeting approved.

III. Chair's Report

Secretary Kevin Anderson opened the meeting by illustrating the Department organizational chart focusing on the Office of Tourism and functions. He then introduced Ms. Liz Fitzsimmons, Managing Director of the Office of Tourism and Film who proceeded to provide an overview of the state of tourism of Maryland. She reviewed the Office's mission and vision statements, its measureable objectives — market expansion, leveraging partnership, maximizing opportunities and transactional outcomes. She described the data collected for the measurements and the leading five (5) differentiators that make Maryland competitive.

Ms. Fitzsimmons presented a comparison of the State's competitors; FY 23 direct tourism consumption taxes collected; the competitive rate of visitation growth; Maryland's market reach; the economic impact of tourism in Maryland; visitor spending; marketing and content of latest campaign; highlights of tourism development for 2024 and 2025; social media outlets. Presentation on file.

Ms. Fitzsimmons then answered questions from the Subcabinet. The discussion included the available data on the economic impact by region; level of spending exceeding inflation; increase in average daily rates of lodging; apprenticeships; status of convention center; and resources needed to increase tourism.

IV. Regional Resources Workgroup

Mr. Joe Griffiths, AICP, Local Assistance and Technical Trainer, Department of Planning addressed the Subcabinet and discussed the progress of a new format to provide items of interest rather than report out of current activity. Mr. Griffiths stated he is working with Team Leaders who continue to be challenged with limited team participation and reporting. Report on file.

Secretary Anderson then presented a concept of a Rapid Business Response Team led by Commerce to address two (2) functions – business retention and expansion for reactive (issues to resolve) and business attraction for proactive (bringing a team together to prevent issues and support attraction). This new team would bring bottlenecks, policy issues, and preemptive solutions to the Subcabinet. He requested the Subcabinet provide Agency points of contact of a level of authority to address, correct, and direct solutions in support of businesses.

Secretary Anderson then proposed the Regional Resource Workgroup eliminate the reporting and meetings, yet continue to list the agency contacts on the webpage.

Secretary Anderson opened the floor for discussion. The Subcabinet discussed the reporting and challenges, and there was no objection to moving forward with the Rapid Business Response Team concept. He requested the Subcabinet provide names to begin the formation of the Team. Memo on file.
