# I. Meeting called to Order

Secretary Harry Coker called the meeting to order at 1:01pm.

#### II. Meeting Minutes – June 9, 2025

Upon a motion duly made and seconded, meeting minutes from June 9, 2025 were approved.

## III. Chair's Report

The Secretary reported on the following topics:

- CNCC state rankings were discussed. Improvement in infrastructure and workforce categories were highlighted.
- "Winning the Decade" Strategy aims to reduce the reliance on federal spending by attracting private capital and foreign direct investment.
- Commerce plans to meet with CareFirst, The Greater Baltimore Committee (GBC) and the Greater Washington Partnership (GWP) on July 21st to discuss best practices in pipeline management, strategic communications, and business account management.
- The Return on Investment (ROI) plan was submitted to the Governor's Office on June 30<sup>th</sup>.
- Progress has been made on the bi-annual consolidated economic competitiveness plan. A template from MDE will be leveraged for the data collection portion of the task. The goal is to consolidate input from the subcabinet members by October/November for a final delivery in November/December.
- An update on trade missions to the UK, Ireland and Scotland were presented. Two international firms expanding to the US via the global gateway program: Safe Tech (UK) and a German quantum computing startup.
- The importance of Foreign Direct Investment (FDI) was discussed. FDI will become increasingly important to pursue since public capital is becoming scarce.
- Pipeline Update as of July 8<sup>th</sup>: 49 total opportunities which includes 24 attractions, 19 expansions and 6 foreign direct investments. These totals represent a potential of 11, 178 jobs and approximately \$14.2 billion in capital expenditure.
- Commerce plans to visit every county to focus on their economic development needs. Recent visits to Prince George's and Dorchester Counties were highlighted.
- CEO dinners are being held in Baltimore City. During the last dinner, the main discussion was on the convention center funds challenges and the need for more strategic planning for the central business district.

# IV. Strategic Plan Phase Two Update

Ms. Smith reviewed the status of the Strategic Plan Phase II activities.

- Commerce generated and submitted a Procurrent Office Determination (POD) to the OSP.
- OSP reviewed Commerce's POD and had no feedback.
- OSP will generate an OSP POD.

- We are now awaiting the final approval of the OSP POD.
- Once the OSP POD is approved, Commerce will release the Strategic Plan Phase II Request for Proposal (RFP).

# V. Working Session – Research Projects Discussion

Mr. Palma reviewed and distributed the proposed research topics for the University of Maryland's Quest Honors Program. Subcabinet members were encouraged to provide feedback on the research topics, including additions or deletions. The list of topics was:
