The meeting was closed to discuss the modification request of Orcana Biotech, LLC and the new request of Fearless DSI, LLC. Both requests were approved.

- 1. Orcana Biotech, LLC Modification to approve the following changes: (1) accept evidence of \$53,000 in equity and waive requirement to provide evidence of total equity of \$153,000; and (2) waive requirement that Kroger provides \$500,000 in orders during the first twelve months and change the disbursement schedule to disburse \$200,000 after any Kroger order
