MINUTES

April 28, 2025

NEW REQUEST

AG Healthcare, Inc.

The closed session of the April 28, 2025, meeting was summarized. The Authority Board meeting was attended by Les Hall, Chuck Martin, Mara Sierocinski, and Sharon Pinder. The meeting was closed to comply with requirements of the Maryland Public Information Act so that there would not be disclosure of confidential, commercial, and financial information associated with the applicants. The meeting was closed to discuss the modification requests of Compost Crew, Inc. and Fearless DSI, LLC; and the new requests of Addison Laundromat, LLC, Josefina Baltimore, LLC, and The Magruder Group, LLC. Both of the modification requests were approved. The new requests for Addison Laundromat, LLC and The Magruder Group, LLC, were also approved.

- 1. Compost Crew, Inc. Modification to increase the loan to a \$1,750,000 term loan for the acquisition of land and construction of the project in Frederick County.
- 2. Fearless DSI, LLC Modification to subordinate the lien in favor of AUB for a \$10 million line of credit, replacing the previous \$13 million line with Truist, and elevating the lien position from third to second.
- 3. Addison Laundromat, LLC New request to approve a \$350,000 term loan from the MSBDFA EPIP program for to establish a second Prolaundry-branded laundromat.
- 4. The Magruder Project Inc. dba Pet Connect (new request) approved amount of \$200,000 in the form of another convertible note, with a term of 48 months and an 8% simple interest rate.
