The closed session of the May 30, 2024, meeting was summarized. The Authority Board meeting was attended by Les Hall, Mara Sierocinski, Chuck Martin, Ben Siegel, and Sharon Pinder. The meeting was closed to comply with requirements of the Maryland Public Information Act so that there would not be disclosure of confidential, commercial, and financial information associated with the applicants. The meeting was closed to discuss the modification requests of DaCore Investment Group dba Shark Bar & Seafood House, Fearless DSI, LLC, and YJ, LLC. All the requests were approved.

- 1. YJ, LLC dba Inca Chicken Modification to allow request to release the MSBDFA collateral lien on 311 Dark Star Way, Glen Burnie, MD 21060.
- 2. DaCore Investments, LLC t/a Shark Bar & Seafood House Modification to allow temporary release on 904 K Street, NE Washington, DC 20002 for refinancing and refile, after the closing of the refinance to retain 2nd lien position.
- 3. Fearless DSI, LLC Modification to allow request: (i) give MSBDFA consent to Fearless DSI, LLC and Fearless Talent, LLC to proceed with the 2 NMTC loans, (ii) consent to Fearless DSI, LLC and Fearless Talent, LLC providing guarantees of the NMTC loans, (iii) agrees to amend its Loan Agreement and any other agreements in connection with the MSBDFA term loan, to exclude the NMTC loan and its loan documents from the definition of Collateral in the MSBDFA Loan Agreement and any other agreements entered into in connection with the Loan, as of the date of the funding of the NMTC, and (iv) will agree to file or cause to be filed a UCC financing statement amendment to its UCC financing statement no. 230628-1129001 with SDAT to exclude the Leverage Loan and the Leverage Loan Documents from the collateral covered by MSBDFA's UCC.
