A long-term extension to October 1, 2026, was requested to allow more time for

the loan to close. It is estimated that the loan (and the loans of the co-lenders)

will not close and funds will not be disbursed until Q3 2026 based on the proposed structure of the loan. Until recently, the Private Lenders were proceeding to close the loans and disburse the loan proceeds if/when the Company hit certain milestones. MMG has been advised by the Private Lenders that they prefer to wait to close the debt financing until the required work is completed and permits have been obtained.

- 1. Anticipated permit delays
- 2. Available capital to make the necessary improvements requiring permits
- 3. The company's access to the USDA Grant
- 4. Disbursement schedule
