## I. Call to Order

Secretary R. Michael Gill called the meeting to order at 10:05am.

#### II. Welcome

Tradepoint Atlantic Executive Vice President of Corporate Affairs, Aaron Tomarchio welcomed the Subcabinet and guests to its new Marketing Center. Mr. Tomarchio reflected on the transformation and development of the 3,300 acre property since its purchase in 2014. He introduced Managing Directors Kerry Doyle and Marc Salotti and Chief Financial Officer David Franchak.

The Tradepoint Atlantic team provided a presentation on the history of the project and commute patterns. They engaged in a discussion with the Subcabinet regarding the diversity of the property tenants; land

leases; current employee population of 13,000-16,250; rail and port capabilities; future demolitions; transportation infrastructure improvements and transit; water and sewer requirements; and future needs. All commented on the success of the project due to the collaborations and cooperation with local, State and Federal governments and the positive marketing of the state.

Secretary Gill began the Commerce presentation by describing several recent successful collaborative activities and announcements with Subcabinet State Agencies – the Governor's Asian Trade Mission, Maryland 5 Star at Fair Hill and the Maryland Fly Fishing Trail. He then introduced Senior Director Mr. Jayson Knott who provided an overview of business attractions and expansion opportunities. Mr. Knott presented recent wins; existing pipeline; and several opportunities, capital expenditures, opportunities and prospective jobs by region. Mr. Knott answered questions from the Subcabinet.
