#### Comments: City First has decided to provide Food Opportunity with an

additional \$125,000 line of credit to support its working capital needs. Proceeds will be advanced against 75% of eligible receivables less than 90 days old and secured by the accounts receivables. All other liens will be subordinate to the City First term loan. The City First LOC brings the total financing to

\$716,500.

City First total loan exposure will now be \$493,850. However, MSBDFA is only guaranteeing the \$368,850 term loan which will continue to have a senior secured position on all assets except for the accounts receivable. Otherwise, the additional line of credit will not negatively impact the term loan's security position. The line of credit will have a positive impact on the company's cash flow.

## **Action Taken:**

The report was accepted as presented. However, MMG was requested to present a modification request during the May 10. 2018, Authority Board meeting.

The Meeting then closed at 1:25 p.m. upon motion made and seconded, and approved by all voting members, the meeting was closed pursuant to General Provisions Article, Section 3-305(b) (13), "to comply with a specific... statutory... requirement that prevents public disclosures about a particular proceeding or matter", that is, the Maryland Public Information Act prohibits disclosure of trade secrets, confidential commercial and confidential financial information.
