I. Call to Order

Secretary Kelly Schulz called the meeting to order at 2:03pm and attendance was taken.

II. Review and approval of October 6, 2021 Minutes

Upon a motion duly made and seconded, the minutes of the October 6, 2021 meeting approved.

I. Agency Administration Accomplishments

Ron Gunzburger, Senior Advisor to the Governor addressed the Subcabinet and requested the Agencies provide their highest Department achievements/legacy projects occurring during the current Administration and any projects in the pipeline. He requested submissions by January 15th. Mr. Gunzburger provided examples and answered questions from the Subcabinet.

II. Chair Update

Secretary Kelly Schulz addressed the Subcabinet and introduced Economist Michael Siers to review three (3) materials the Maryland Economic Development Commission has developed with the Research Team to guide recommendations and strategies related to the State's economy. He described a Rankings Report, Dashboard of high frequency data and a new Maryland Neighborhood Needs Index (MNNI). The Commission reviewed these documents at their November meeting and suggested that staff present to the Subcabinet for input or any suggestions to assist with Agency programs. The Subcabinet was requested to review and provide any input in the next few weeks.

The presentation was continued by Senior Director Jayson Knott who provided an overview of business attractions and expansion opportunities. He presented recent wins; existing pipeline; and number of opportunities, capital expenditures, opportunities and prospective jobs by region. Presentations on file.

III. 2022 Legislative Priorities

Subcabinet Secretaries provided their Agency highest overall priorities for the upcoming legislative session.

IV. I-495 & I-270 Traffic Relief Plan and Purple Line Updates

Deputy Secretary Earl Lewis, Jr. addressed the Subcabinet and provided updates on two (2) major projects – the I-495 & I-270 Traffic Relief Plan and the Purple Line that have significant impact on the State's economy. Deputy Secretary Lewis reviewed the routes, status of contractors, economic impact, phases, and the Opportunity MDOT program of the Traffic Plan. He addressed predevelopment work, toll rate setting process and benefits to the State. Deputy Secretary Lewis answered questions from the Subcabinet. Presentation on file.

The Leaders of the six (6) Workgroups gave presentations: Small Business, SM3, Regional Resources, Customer Service, Job Creators, and Workforce Development. Reports are on file.
